

I, _____ (hereinafter called the "Client") hereby request a reservation to breed my mare _____ AQHA# or APHA# _____ to Skip N Wess AQHA # 3536402. Stud fee is to include a \$200.00 non-refundable booking fee. It is agreed that the breeding fee will be a total of \$950.00 which includes booking fee and must be paid in full before first breeding or shipment of semen. If you wish to AI mare there is an additional breed fee of \$250.00 will include the first collection and shipment of semen to your veterinarian. Any further shipments will be charged at \$300.00. You will be responsible for mare insemination and veterinary service for the mare. Mare care \$8.00 per day/wet mare \$10.00 per day.

Mare shall be in healthy, sound breeding condition. The mare should have received routine vaccinations, be current on worming and a licensed veterinarian's certificate confirming breeding soundness shall be required prior to breeding or shipment of semen. A copy of both sides of mare's registration certificate shall also be required prior to breeding or shipment of semen and become permanent property of the stallion owner.

Mare should be ultra sounded with sixteen (16) to eighteen (18) days following the last breeding date and palpated at forty-five (45) to forty-seven (47) days after last breeding date. Written veterinarian certification of ultra sound and palpation shall be provided to stallion owner. Pneumobort K (Rhinopneumonitis) vaccinations must be administered to the mare on her 5th, 7th, and 9th month of gestation. **Failure to do this will void the Live Foal Guarantee.**

Live foal guarantee: Live foal means the foal shall stand and nurse. It is understood if the mare is barren, aborts her foal, or if foal is stillborn a return season is guaranteed for the following year only, providing proper notification is given. Proper notification is a written certification by a licensed veterinarian within seven (7) days of the incident. Guarantee does not include death from injury or illness to the foal. Mare owner certifies that such abortion or death did not result from any act or omission of the Owner. Mare owner agrees Stallion Owner does not make any guarantees as to the quality, or conformation of the foal or that foal will be free of any infirmity, conformation defect, disease, or inherited trait. It is further agreed that if contracted stallion dies, or becomes unfit for breeding, this contract is null and void unless owner has a replacement stallion at the time of death, if there is no replacement stallion, booking fee will be returned to Mare owner.

A breeders certificate will be issued to Mare Owner upon notification of birth of foal providing all expenses owed to Stallion owner for services are paid in full.

The mare owner agrees to use the shipped semen only on the mare named above in this contract and shall have a licensed veterinarian verify in writing that the shipped semen has been used only to inseminate the mare named above in this contract as evidenced by the enclosed "Collection/Insemination Certificate partially filled out by Stallion owner, and to be filled out by Mare owner and signed by Veterinarian inseminating the mare. This certificate needs to be returned to Stallion owner. It will be the responsibility of the Stallion owner to see that AQHA receives their copy.

Mare owner shall be responsible to call Stallion owner by 10am PST, to assure the next day delivery of semen from stallion.

When owner of mare signs this contract and returns one copy of this contract along with the non-refundable booking fee of \$200.00 it will be a binding contract on both parties, subject to the above terms and conditions.

This contract is non-assignable and non-transferable.

This contract represents the entire agreement between the parties. No other agreements or promises, verbal or implied, are included unless specifically stated in this written contract or in another written agreement between both parties.
